  - o communicating and consulting with parents
- Promoting the general progress/wellbeing of any individual group of pupils assigned to you.
- Advising and co-operating with the Headteacher, Senior Leaders and other teachers on the preparation
  and development of courses of study, teaching programmes, methods of teaching, assessment of
  pastoral arrangements and teaching materials.
- Maintaining good behaviour management and discipline among the pupils and safeguarding their health and safety both when they are on the school premises and when they are engaged in authorised school activities elsewhere.
- Co-ordinate an agreed After School Club throughout the year.
- Work with other Key Stage staff to supervise lunch and play duties.
